The Santa Barbara County Arts Commission presents, ***Visual Inquiry: Mixed Media, an*** exhibition of regional artists curated by John Hood, from February 23 – May 22, 2009 at the Betteravia Government Center, 511 E. Lakeside, Santa Maria. The opening reception will be Wednesday, February 25, from 4-6pm.

Visual Inquiry: Mixed Media brings together former students of Allan Hancock College, all now exhibiting artists in the community; and current students from the Santa Maria area. The twelve artists include: Karen Carson, Denise Chavoya, Sandra Clouse, John Dilenger, Becky Hellwig, Felicia Kincaid, Dana Litzenger, Jonathan Lord, Claire Milburn, Juan Manuel Perez, Ariana Sarinana and Carey Reimer. The mixed media exhibition brilliantly brings into play all the artistic license artists can bring to bear - utilizing standard images from photography, printmaking, painting and drawing to the wilder side of puzzle pieces, newspapers, sea shells, and yes, even chicken wire.

John Hood is an exhibiting artist and Instructor of Art & Design at Allan Hancock College, and Arts Commissioner from the 5th District.
